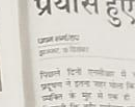

Couple found hanging in flat, note says they had ₹50L loan

Sent Son To Granddad; Note Says Landlord Harassed Them Too

Gurgaon: A 20-year-old son was found hanging by his father in a flat in Sector 29, Gurgaon, on Tuesday. The police recovered the body from the ceiling fans of the flat. The couple had a loan of ₹50 lakh and alleged harassment by the landlord.

Pankaj Gupta (40) and his wife Renuka (40) were found hanging from the ceiling fans of the third-floor flat. Hours earlier, they had dropped the 22-year-old son with Pankaj's father, Mukuldev DCP (trans-Haryana) Nishidh Pathi, who received a call from Mukuldev around 10pm on Tuesday.

"Pankaj routinely dropped his son at his father's house in Rajendra Nagar and picked him up in the evening. We were mentally unstable," he added. "When he did not collect his son in the evening, his father contacted Pankaj's elder brother, Raj Kumar, who went to the flat and found the couple hanging from the fan."

Preliminary investigation revealed that the couple was burdened with debts exceeding ₹50 lakh, primarily for Pankaj's restaurant venture.



The couple expressed their desire to live but said with no choice

he failed to take off in Delhi a year ago. Police said they recovered a diary from one of the rooms, containing nine pages of notes discussing the family's financial troubles and intention to end their lives.

In one of the pages, Pankaj reportedly expressed his desire to live but claimed circumstances left them with no choice. He accused his business partner of causing him losses in the restaurant project.

"He specifically named one Dhanya Negi as the primary cause of their financial trouble. After legal disputes, fraudulently taken loans

from him but never repaid them. Pankaj accused Negi of exploiting his position as a business partner at the Delhi safe lending to the extent that closure," an officer said.

The note also spoke about troubles the couple faced with their rented flat. Pankaj requested his wife to either take care of his son or entrust his responsibility with his wife in Delhi.

Pankaj, according to cops, mentioned paying ₹6 lakh to one Madan Lal in 2008 for the flat. But after legal disputes during the pandemic, the property was bought by Theo Lentina

Woman (20) killed, husband main suspect

Gurgaon: A 20-year-old woman was killed allegedly by her husband at their house in Bahadurgarh, Gurgaon, on Tuesday night.

Chitra, who reportedly claimed to be a relative of boxer Mary Kom, would reportedly send police to pressure the couple to vacate the property.

A note left by Renuka mentioned seven persons — Theo Lentina, Chitra, Sheela Singh, Dhanya Negi, Rajat Tomer, Harinder, Meena (Pankaj's ex-wife) and Prabhat Kumar, accusing them of driving them to suicide.

The police probe also revealed a complex personal history of the couple.

Pankaj was divorced twice, while Renuka had one previous marriage. Renuka's two daughters from earlier marriage live with her ex-husband in Mumbai, police said.

Additionally, Pankaj was involved in a legal dispute with his first wife's partner, Meenu, a Delhi resident, since 2014. While family members claimed they were married, there were conflicting reports about their relationship.

Police have seized the couple's mobile phones and are analysing call records.

Woman slaps six-year-old boy arguing with her son, FIR filed

Noida: A playground quarrel between children at Gaur City's 9th Avenue on Tuesday afternoon turned into an ugly brawl between their mothers when one of them slapped the six-year-old son of the other, leaving a bruise on his cheek.

Chanchal Saini, the mother of the boy who was slapped, said her son was playing with his friend at their house in Bahadurgarh on Tuesday night.

The situation intensified when the other child called his mother and accused the other two kids of picking up a fight with him. The woman, Seema Thakur — then allegedly slapped Saini's son with "considerable force".

"She grabbed both my son and his friend by their hands and dragged them to me. 'Control your children, they are hitting my son, she shouted at me and my friend

slapped him hard. It had turned black and blue," Saini said.

Other residents who were taking a stroll under the afternoon sun confirmed that the boy had been hit. Saini confronted the woman about slapping her child on the spot, but she refused to apologise further. "Before I could question her actions, she began verbally abusing me and even threatened to harm my child again," she alleged.

Seema — a beautician — even assaulted Saini's friend when she attempted to record a video of the incident. The boy's father lodged a police complaint, following which an FIR was registered against Seema under BNS 155 in Sector 105, Noida, which addresses voluntarily causing hurt, and 202, which deals with acts of provocation and subsequent assault committed under provocative circumstances.

The result comes close to the Gurgaon society where a sting on a similar incident between children and even pointed a gun at the boy trying with his son.

Prateek Satharia, a resident of Ambience Lagoon and a lawyer by profession, was arrested and released on bail on Nov 22 following a police complaint lodged by the father of the boy who was threatened.

Karen, Lohia, a real estate agent who lives in the same condominium, his 12-year-old son was playing football with other children when the kids had an argument.

Satharia's son went to his flat and called his friend. "The businessman came down, abusing all the kids in the park. He even threatened to kill my son while pointing a gun at him," Lohia alleged.

Trader charged under conversion law after partner dies by suicide in Noida

Gurgaon: A 38-year-old man was charged under provisions of the UP Prevention of Unlawful Conversion of Religion Act after being accused by the father of the woman he was married to.

The 38-year-old woman was married to a man who died by suicide in Noida on Dec 11 after her wedding plans with Parag, a friend, fell through. The woman's father alleged, "she married Parag after he fell ill in the 70-year-old, who has lung cancer and suffered a brain stroke and was hospitalised. But she married him, set conditions for her marriage, and then Parag died in an accident. She then married me and I am now a widower. She has converted her religion to Islam."

Police said they had filed the charges after investigation revealed a "conspiracy".

Altaf, a resident of Sector 105 in Noida who runs a ladies' garments store in the city, was also booked under BNS sections for abetment to suicide. In his complaint, the woman's father said he had married his daughter to Parag, but she had converted to Islam and married him. He had seen her in Noida, where she had stopped to buy clothes on Nov 14. After he was admitted to hospital, she visited him in Noida. He said he was shocked when she came to meet him and sought his permission to marry his daughter. "He promised to keep her very happy and to stay with me during my illness. She was very ill, going through a huge shock. He took advantage of my mental and physical condition and convinced me to agree," he alleged, adding that she had more than one abortion during her relationship with Altaf who was sexually assaulted her.

Pankaj Kumar, DCP, city, said an in-depth investigation into the reasons behind the young woman's suicide had revealed a conspiracy. Police cited chats on her cellphone, recordings of her conversations with Altaf found on the phone, copies of the Quran and Health that she had to back her case.

All the transactions and expenses were handled by my daughter. On Dec 3, she told me she had prepared all the wedding papers, but Altaf was trying to postpone the wedding. On Dec 10, she informed me that she had decided her and didn't love her. He kept postponing and making a condition that she should transfer her property to him and convert to Islam properly. She said she was only allowed to marry him if she converted to Islam. She was after her son with ₹20 crore," the DCP added.
